2010 Blackberry Oaks Membership Agreement and Policies

1. Blackberry Oaks Golf Course agrees to provide the purchaser with unlimited golf except for participation in golf outings. This agreement is based on availability due to leagues and golf outings. A monthly calendar will be sent to each member with scheduled dates of leagues and outings.
2. Permanent Tee Times are available on weekends only. These times are available on a first come first serve basis. The sooner you join, the earlier time you are able to reserve. Please be advised that Blackberry Oaks does already have an established group of permanent tee times so availability is limited. If a weekend permanent tee time is desired, the member and his group will have to abide by the rules and regulations regarding permanent tee times, along with deposit requirements.
3. Members may book tee times up to 14 days in advance.
4. Members will receive discounts on in stock merchandise.
5. Members will receive reduced cart fees of \$10.00 for the day of play, regardless of number of holes played that day.
6. Members will receive reduced range fees of \$5.00/bucket or may purchase a season pass of unlimited range balls for \$275.00.
7. Members will have all greens fees waived for participation in Blackberry Oaks Tournaments and Events.
8. Members will have the ability to set up a charge account with a valid credit card on file. Members with a charge account will receive a statement at the end of each month reflecting your charges. Payment must then be made within 30 days. If the balance is not received in 30 days, your credit card will be charged.
9. All members are required to register with the Golf Shop prior to play each time. Failure to do so will void your membership.
10. Members are required to play the golf course in sequential order. Members will NOT be allowed to skip holes. This agreement will be strictly monitored and failure to comply will void your membership.
11. The membership fee is non-transferable and is only valid for the member on file. Refunds of the membership fee (once paid) will NOT be allowed.
12. There will be no payment plans in place for a membership purchase. The membership fee must be paid in full upon joining Blackberry Oaks.
